In order to expedite Custom's clearance on your behalf, Unitrans International Corp. is required to have a U.S. Customs Power of Attorney on file. To facilitate this procedure, please fill out the following form according to the following instructions:

Please type or hand-write clearly. Please use **blue** ink. Please do not make any corrections or use white-out. Any correction to the form will require a new form to be issued.

The following points correspond to the actual Customs Power of Attorney form:

- 1) Company IRS/EIN Number or Individual's Social Security Number.
- 2) Check the appropriate box for the type of business
- 3) The name of the business
- 4) The type of business – this should agree with No. 2
- 5) The state where the business is incorporated or organized
- 6) The address where the business is located
- 7) & 7a) Grantee's Name = Unitrans International Corporation
- 8) Full Name of Company
- 9) Signature and printed name of person who is authorized to sign on behalf of the business
 - a. If a **corporation** – only the President, V.P. or Treasurer (Corporate Officer)
 - b. If a **partnership**, the reverse side of the form must be notarized.
- 10) Capacity of person signing POA
- 11) Effective date of the Power of Attorney

Perform any act or condition which may be required by law or regulation in connection with such merchandise deliverable to said Grantor; to receive any merchandise;

Make endorsements on bills of lading conferring authority to transfer title; make entry or collect drawback; and to make, sign, declare, or swear to any statement or certificate required by law or regulation for drawback purposes, regardless of whether such document is intended for filing with Customs;

Sign, seal and deliver for and as the act of said grantor any bond required by law or regulation in connection with the entry or withdrawal of imported merchandise or merchandise exported with or without benefit of drawback, or in connection with the entry, clearance, lading, unloading or navigation of any vessel or other means of conveyance owned or operated by said grantor, and any and all bonds which may be voluntarily given and accepted under applicable laws and regulations, consignee's and owner's declarations provided for in section 485, Tariff Act of 1930, as amended, or affidavits or statements in connection with the entry of merchandise;

Sign and swear to any document and to perform any act that may be necessary or required by law or regulation in connection with the entering, clearing, lading, unloading, or operation of any vessel or other means of conveyance owned or operated by said grantor;

Authorize other Customs Brokers duty licensed within the territory to act as grantor's agent; to receive, endorse and collect checks Issued for Customs duty refunds in grantor's name drawn on the Treasurer of the United States; if the grantor is a nonresident of the United States to accept service of process on behalf of the grantor;

And generally to transact Customs business, including filing of claims or protests under section 514 of the Tariff Act of 1930, or pursuant to other laws of the territories, in which said grantor is or may be concerned or interested and which may properly be transacted or performed by an agent and attorney;

Giving to said agent and attorney full power and authority to do anything whatever requisite and necessary to be done in the premises as fully as said grantor could do if present and acting, hereby ratifying and confirming all that the said agent and attorney shall lawfully do by virtue of these presents:

This power of attorney to remain full force and effect until revocation in writing is duly given to and received by grantee (if the donor of this power of attorney is a partnership, the said power shall in no case have any force or effect in the United States after the expiration 2 years from the dates of its execution);

Appointment as Forwarding Agent: Grantor authorizes the above Grantee to act within the territory as lawful agent and sign or endorse export documents (i.e. commercial invoices, bill of lading, insurance certificates, drafts and any other document) necessary for the completion of an export on grantor's behalf as may be required under law and regulation in the territory and to appoint forwarding agents on grantor's behalf;

Grantor acknowledges receipt of 7a. Unitrans International Corporation Terms and Conditions of Service governing all transactions between the Parties.

Importers who wish to utilize this procedure must contact our office in advance to arrange timely receipt of duty checks.
